Jenner & Block lawyers delivered excellent business advice and counsel, secured exceptional trial and appellate victories for our clients, and made 2002 our most successful year yet. Here is a representative sampling of some of our most significant wins in the courtroom and the boardroom this past year.

Litigation

The U.S. Supreme Court handed down a significant victory on behalf of client **WorldCom, Inc.** in May, upholding the FCC's pricing rules intended to introduce competition into the market for local phone service as mandated by the Telecommunications Act of 1996. The 7-1 decision ends more than six years of litigation over the meaning of the critical market-opening provisions of the Act regarding the pricing methodology and other rules governing the sharing of the incumbent local service providers' networks.

In the Firm's second U.S. Supreme Court victory for **WorldCom, Inc.** in May, the Court ruled 8-0 for our client in an important telecommunications case, *Verizon v. Maryland*, rejecting claims of state utility commissions that the 11th Amendment barred federal court suits against them to enforce provisions of the federal Telecommunications Act of 1996. The decision involving "reciprocal compensation" protects hundreds of millions of dollars in judgments that Jenner & Block has obtained on behalf of WorldCom in over 25 cases against the Bell Companies for breaching agreements under which they promised to compensate WorldCom for delivering calls to Internet Service Providers.

Jenner & Block represented the **State of Illinois** in the mediation of a dispute about the size of the contingency fee to be paid to four law firms that represented the State in litigation against the tobacco industry. Following the settlement of the tobacco

industry suit, the law firms had demanded nearly \$900 million or 10% of the \$9 billion to be paid to Illinois, pursuant to their agreement with the State. As a result of the mediation, the law firms will receive only 2% or approximately \$188 million – saving the State and the people of Illinois more than \$700 million and ending over three years of litigation.

An arbitrator denied a request by Amgen to terminate **Ortho Biotech's** long-standing license to sell an anemia treatment that is a top-selling drug of Ortho's parent **Johnson & Johnson**. In a case tried over a four-month period, Amgen sought to terminate Ortho Biotech's U.S. license and to recover damages of \$1.24 billion, but the arbitrator not only upheld Ortho's license but also rejected nearly 90% of Amgen's claimed damages. Johnson & Johnson hailed the decision because it will retain the rights to Procrit, which accounted for \$2.3 billion in sales last year.

The California Supreme Court granted insurance coverage to Firm client **Kraft Foods** for hundreds of underlying personal injury cases, affirming the trial court's decision and reversing the Court of Appeal in *Dart Industries v. Commercial Union Ins. Co.* The opinion was the first in which the court addressed "what an insured must prove... to establish its rights under a lost or destroyed insurance policy" and the first time in many decades that the court spoke to the requirements for proving the terms of a lost document.

In a significant ruling for **federally chartered savings associations**, a Missouri trial court granted the Firm's motions to dismiss on behalf of several mortgage lenders in the state, holding that federal law preempts state law claims involving the charging of borrowers' fees for the preparation of mortgage documents. The victory, based on a federal preemption defense, followed two other significant victories by the Firm for federal savings associations in Illinois state courts in 2002 – one also defeating claims involving the charging of document preparation fees, and another involving payoff statement fees.

The Illinois Appellate Court affirmed a lower court decision rejecting the

Merchandise Mart lender's claim for a \$47.4 million prepayment penalty associated with the 1998 sale of the Boston-based Kennedy family property. The upholding of the three-year-old Cook County Circuit Court decision allows the Firm's client, **Merchandise Mart Owners LLC**, to keep the escrowed amount.

The Firm successfully defended **General Dynamics** in a *qui tam* suit brought under the False Claims Act in which the relator, who sought damages in excess of \$4 billion, alleged that the company defrauded the U.S. Navy and the Congress to obtain a contract to manufacture a Seawolf-class nuclear attack submarine, the SSN-23 (Jimmy Carter). The United States district court in Charleston, South Carolina granted summary judgment in favor of our client, dismissing the lawsuit.

The U.S. Court of Appeals for the Fourth Circuit vindicated the right of a non-profit client to speak out on public issues. The manufacturer of a medical device had sued the Firm's client, **a medical professional association**, for publishing a negative review of the manufacturer's new technology. The Firm prevailed in the trial court and subsequently in the Fourth Circuit on First Amendment grounds.

A Jenner & Block trial team won a federal court jury verdict for **Flair Corporation** in an employment discrimination case in Florida. At trial, the team demonstrated that plaintiffs' claims were without merit, and that Flair paid and promoted its employees based on their relative skills, experience and proficiencies. Based on the jury's verdict, the Court dismissed plaintiffs' claims in their entirety and ordered that Flair, a division of SPX Corporation, recover its costs in connection with the lawsuit.



The Seventh U.S. Circuit Court of Appeals affirmed the grant of summary judgment in favor of Firm client **Nuveen Advisory Corp.**, the investment advisor to various Nuveen Investment funds, ending class action litigation that began in 1996 regarding an alleged conflict of interest. The appellate court rejected plaintiffs' theory of the case as both legally unsound and negated by the undisputed facts.

The Firm helped its client **Pechiney Plastic Packaging, Inc.** resolve complex patent litigation that had been pending for several years, by first aggressively litigating and later successfully mediating a settlement that resolved the dispute amicably and consistently with Pechiney's business objectives.

In a significant decision for Firm client **Commonwealth Edison**, the Illinois Supreme Court denied a petition for leave to appeal in a nuclear decommissioning case, thereby concluding a significant case of first impression and preserving the Exelon Corporation subsidiary's right to collect \$438 million in decommissioning charges. The Firm also represented ComEd before the Illinois Court of Appeals, which affirmed the authority of the Illinois Commerce Commission to approve the collections and the transfer of ComEd's decommissioning liability to its unregulated affiliate, as part of a move to deregulate and foster competition in the state's electricity markets.

In a victory for the Firm's clients including the **American Library Association**, the federal statute requiring Internet filters in libraries was ruled facially unconstitutional and in violation of the First Amendment, according to the U.S. District Court for the Eastern District of Pennsylvania. The court ruled that public libraries are not required to install filters on their computers in order to receive federal funds under the Telecommunications Act and the Library Services and Technology Act. The case is now before the U.S. Supreme Court.

Jenner & Block successfully represented its long-term client, **Hitachi Ltd.**, and one of Hitachi's U.S. subsidiaries in a number of cases against the Taiwanese memory chip manufacturer Mosel Vitelic, Inc. and one of Mosel's U.S. subsidiaries. The cases included a breach of contract case brought by Hitachi in the Superior Court for Santa Clara County California, two patent infringement cases in the Northern District of California and a proceeding before the International Trade Commission in Washington, D.C.

The Sixth U.S. Circuit Court of Appeals reversed the District Court's ruling in *Grutter v. Bollinger*, and ruled that the University of Michigan Law School admissions policy, which seeks to admit a diverse student body, does not violate the Equal Protection clause. Firm attorneys filed an important *amicus* brief in *Grutter* and the related *Gratz* case on behalf of **more than 30 Fortune 500 companies** and major American businesses who believe, as the University does, that diversity is a compelling state interest that the University can constitutionally consider in admitting students.

The Firm negotiated a favorable out-of-court settlement for **Cablevision Systems Corp. chairman Charles Dolan**, in the midst of a second trial on claims of breach of fiduciary duty arising out of the introduction of cable television to the Chicago metropolitan area. The settlement ended seven years of litigation, including a first trial that resulted in a jury award for plaintiffs that was thrown out on appeal.

In a victory for **members of Pennsylvania's congressional delegation**, Firm attorneys convinced a three-judge panel to strike down the state's redistricting map on constitutional grounds. The panel ruled that the political party that controlled the state legislature, and therefore controlled the redistricting process, had overreached.

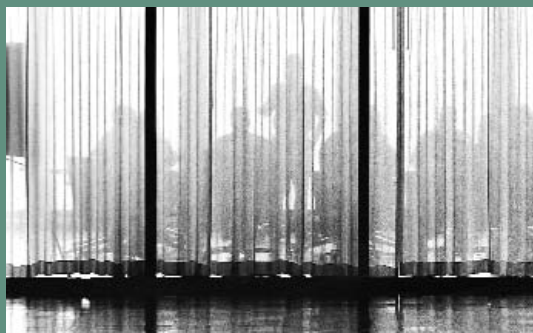
In a case of first impression, the Illinois Appellate Court ruled that Jenner & Block's client, federally-chartered savings association **Washington Mutual Bank, FA**, could not be sued under state consumer fraud laws for charging mortgage loan pay-off statement fees because such claims are "preempted" under the enabling regulation promulgated by the Office of Thrift Supervision under the 1933 Home Owners' Loan Act.

In a case of first impression involving the state's choice of law rules, the Illinois Appellate Court upheld a trial court's finding that materials at issue in a lawsuit were not protected by the attorney-client privilege. The decision was a victory for **Sterling Finance Management**, which Firm attorneys successfully represented at both the trial and appellate levels in the discovery dispute and related contempt proceedings.

The Firm successfully represented **SPX Corporation** in a commercial arbitration involving the sale of a business unit when the arbitrator ruled in favor of SPX on respondent's claims for fraud and breach of a patent litigation settlement agreement, and issued an award of \$11 million to SPX. The five-day arbitration hearing was held, and the award issued, within 11 months of Jenner & Block's retention.

In a victory for the Firm in a case with national interest, the Illinois Supreme Court reversed by a 5-2 vote an earlier 4-3 decision after rehearing in *SWIDA v. National City Environmental (NCE)*. At stake was whether Illinois' "quick take" eminent domain statute may allow a state agency to condemn private property and to transfer it to another private party whom the state agency believes can use the property more profitably, or in a manner to generate more tax revenues. Illinois' high court ruled in favor of Jenner & Block's client NCE that the state's "quick take" condemnation law had been "improperly used."





corporate transactions

The Firm's corporate lawyers represented **General Dynamics** in several important corporate finance transactions, including the registration and exchange of \$500 million of freely-tradable floating-rate notes for similar unregistered notes, as well as the negotiation and documentation of a bank credit facility for approximately \$1 billion.

Jenner & Block also represented **General Dynamics** in transactions including the sale of the company's space propulsion business and the acquisition of Command System Incorporated, a command and control software company. In addition, the Firm's corporate department represented General Dynamics in its acquisition of a publicly-traded company, Advanced Technical Products, Inc., which now is part of General Dynamics Armament and Technical Products. The Jenner & Block team was able to meet both parties' goal of completing the acquisition in an accelerated timeline of less than 90 days from start to finish.

The Firm demonstrated its multidisciplinary capabilities on behalf of client **Lante Corporation**. Our corporate lawyers represented Lante in its sale to SBI and Company by means of a cash tender offer. When lawsuits were brought to prevent the closing of the transaction, the Firm's litigators successfully defended Lante and its directors, thus allowing the transaction to proceed to closing.

Multidisciplinary efforts were also required when the Firm represented **Midland National Life Insurance Company** in a complex transaction to acquire Clarica Life Insurance Company and its non-reinsurance affiliates. This required significant tax and employee benefits counseling in addition to the services of our corporate attorneys.

Similarly, the Firm's finance, tax and M&A lawyers represented **Insure One Independent Insurance Agency** in a complex transaction involving the sale of substantially all of its assets, including those of more than 100 of the company's Midwestern offices.

For **American Tool Companies**, our corporate lawyers successfully closed the sale to Newell Rubbermaid, a shareholder of American Tool, of all the common stock owned by the other shareholders.

The Firm represented **Technology, Management & Analysis Corporation** and its shareholders in its sale to L-3 Communications Corporation, and **Chicago Faucet Company** in its sale to Geberit, AG, a Swiss publicly-held corporation.

Jenner & Block corporate lawyers represented **Florida East Coast Industries** in the sale of its wholesale telecommunications transport subsidiary, EPIK Communications, to Odyssey Telecorp. This transaction was accomplished through an innovative structure that provided both substantial tax benefits for our client and important working capital for EPIK's continued operations.

The Firm's corporate and commercial finance practice represented a number of clients, including **LaSalle Bank, Deutsche Bank Trust Company, Heller Financial, Inc., General Electric Capital Corporation, The Northern Trust Company** and several corporations in structuring, negotiating and closing many syndicated and stand-alone credit facilities, workouts and loan restructurings.

The Firm represented **Inland Real Estate Exchange Corporation** in a dozen private placements of interests in Delaware Business Trusts that own real estate leased on long-term net leases to high-credit

tenants. In doing so, the Firm's attorneys created an innovative structure that offered substantial financial benefits in comparison to the tenancy-in-common structures more typically used by other sponsors.

Other real estate-related transactions included representing **M Development** in its acquisition and redevelopment of high-end condominiums in the Ambassador West Hotel, as well as representing **Jupiter Realty** in several projects, including the development of a medical office building for the University of Illinois and the acquisition of several multi-family housing developments.

The Firm's corporate, securities, finance and employee benefits lawyers represented **State Street Bank & Trust Company**, as Trustee of an Employee Stock Ownership Plan that acquired 100% of the capital stock of Scitor Corporation, a Washington, D.C. defense contractor, using an S-Corp ESOP structure to pass ownership of the company to the next generation of its employees.

The Firm's employee benefits lawyers also advised **SPX Corporation** in many corporate transactions, including SPX's divestiture of C&M Conveyor and Sunflower Manufacturing Company and its acquisitions of Balcke Cooling Products, Daniel Valve Company and Vance International.

Over a period of approximately five months, the Firm advised a Special Committee of the Board of Directors of **Gemstar-TV Guide International, Inc.** in connection with a management restructuring transaction involving the company's largest stockholder, The News Corporation Limited, and the company's CEO. The transaction involved consideration of complex corporate governance, securities, intellectual property, employment and executive compensation issues, including several matters of first impression with the Securities and Exchange Commission under the Sarbanes-Oxley Act.

bankruptcy

Before the U.S. Supreme Court, the Firm successfully argued for **NextWave Personal Communications Inc.**, that billions of dollars worth of wireless phone spectrum licenses that the FCC had sought to repossess should be returned to NextWave. Earlier, the Firm had convinced the United States Court of Appeals for the D.C. Circuit to invalidate the FCC's attempted cancellation of the licenses after NextWave failed to make installment payments on them while in bankruptcy. The Supreme Court's ruling was hailed as vital to the efficacy of the Bankruptcy Code to protect companies from government creditors.

Jenner & Block provided extensive bankruptcy and restructuring advice in representing **Covanta Energy Corporation** and 123 of its affiliates as co-counsel in their complex Chapter 11 bankruptcy reorganization proceedings filed in the Southern District of New York, including representing our client in bankruptcy-related litigation with dozens of parties. That representation included an important expedited appeal to the U.S. Court of Appeals for the Second Circuit concerning the jurisdiction of federal district courts to issue orders that interfere with the ability of bankruptcy courts to administer complex bankruptcy proceedings. The Second Circuit not only expedited the appeal and issued a stay pending its decision, but ultimately vacated the federal district court's permanent injunction that had enjoined our client from seeking relief from the Bankruptcy Court.

The Firm successfully represented **Baxter Healthcare Corporation**, the holder of preferred shares of the debtor, in the Dade-Behring bankruptcy proceedings. Hired shortly before the pre-negotiated proceeding began, our attorneys vigorously litigated issues relating to valuation and self-dealing, to enable the plan of reorganization

to be confirmed and consummated within the aggressive time deadlines set by the bankruptcy court at the debtor's urging. We achieved a settlement for our client of its claim on very favorable terms.

The Firm obtained an \$8.6 million summary judgment award for its client, **Daniel Freeland, Trustee** of the bankruptcy estate of Consolidated Industries Corporation. On behalf of the Trustee, the Firm argued that certain monies had been transferred improperly from Consolidated to its then corporate parent (Welbilt Corporation) in the year preceding the bankruptcy filing.

The Seventh U.S. Circuit Court of Appeals upheld a district court ruling and ordered Haagen-Dazs Company to pay Firm client **SNA Nut Company** more than \$1 million. SNA, a debtor in Chapter 11 bankruptcy, had sued the ice cream company for the alleged breach of five supply contracts under which SNA had acted as its exclusive supplier of nut products, providing it with almonds, walnuts and macadamia nuts processed under jointly-developed recipes.

The Seventh U.S. Circuit Court of Appeals overturned a preliminary injunction entered against the Firm's client **Reuters**, the global provider of news, financial information and technology solutions, rejecting a claim by plaintiff FutureSource that Reuters had improperly stopped accepting streaming financial news and data from the company and remanding the matter to the federal district court.

The Firm successfully defended against an attempt by asbestos plaintiffs' law firms to void the transfer to **McDermott Incorporated** of \$622 million in assets from McDermott's subsidiary, The Babcock & Wilcox Company. An important step in the resolution of the bankruptcy proceedings of Babcock & Wilcox, the victory came when a federal bankruptcy court judge in New Orleans ruled that Babcock & Wilcox was solvent at the time of the transfers.

business services

The Firm successfully negotiated a settlement with the Department of Justice whereby **General Dynamics Ordnance and Tactical Systems** will conduct a remedial investigation and feasibility study at Illinois' Crab Orchard National Wildlife Refuge Superfund Site, and assist the U. S. Fish and Wildlife Service with a baseline risk assessment, while sharing with several other parties any costs to be incurred.

For **Cole Taylor's directors and officers**, the Firm's insurance litigation team won a summary judgment in a Delaware federal court that entitled our clients to \$30 million of excess coverage on a run-off policy issued by National Union/AIG, thereby providing a total of \$60 million of coverage. The decision facilitated a larger \$140 million settlement of all claims.

On behalf of **General Dynamics**, the Firm tried before the Armed Services Board of Contract Appeals important legal issues relating to the cost allowability of legal fees and the penalty provisions of the Federal Acquisition Regulations. The case involved General Dynamics' right, as the prevailing party in a case under the False Claims Act, to recover its attorneys fees from the federal government. The ASBCA issued a decision in June sustaining our client's position on all grounds, and General Dynamics also prevailed in September, when the Government moved for reconsideration.

Firm attorneys successfully petitioned the United States Patent and Trademark Office to reexamine a United States patent that was being asserted in litigation against **SkillSoft Corporation**. After completing its reexamination, the PTO then determined that all claims of the patent were anticipated by prior publications and subsequently, pending the outcome of the patent owner's appeal, the court dismissed the litigation against SkillSoft.

In November, *American Lawyer* magazine noted that by "sticking to its strategic plan" to grow its corporate practice and hiring "two M&A heavyweights" – **Elmer Johnson** and **Robert Osborne** – Jenner & Block had landed the veritable "mother lode."

Indeed, the national magazine concluded: "What more could one hope for from two lateral hires?"

The Firm would voice similar praise to all of its attorneys, those who joined during 2002 and those who have served the Firm and its clients for as long as half a century.

Mr. Osborne joined the Firm from Kirkland & Ellis, where he had practiced corporate law since 1979. He also served in an outside capacity as General Counsel of Lands' End, Inc. from its IPO in 1986 through 1995, and continued as special counsel to its board of directors thereafter until the sale of the company to Sears in 2002. Mr. Osborne has represented General Motors Corporation and other companies in numerous acquisitions, divestitures and securities offerings, including many transactions that were the largest of their kind.

Mr. Johnson had most recently served as president and chief executive officer of the Aspen Institute, a global forum for corporate leaders. He is a well-known corporate lawyer who served in various capacities at General Motors Corporation from 1983 to 1988, including as General Counsel, Executive Vice President and member of the Board of Directors. Prior to joining the Aspen Institute, Mr. Johnson had been a partner in the law firm of Kirkland & Ellis for 27 years, including serving as a managing partner for much of that time.

Donald Batterson joined the Corporate Practice as a partner. Mr. Batterson is an experienced M&A and securities lawyer who has represented numerous public and private companies in large and complex transactions. Before joining Jenner & Block, he was a corporate partner at Kirkland & Ellis.

Denise Burn joined Jenner & Block from Katten Muchin Zavis Rosenman. She has represented agent banks and commercial lending institutions in the structuring and documentation of complex secured and unsecured domestic and cross-border financing transactions in a variety of industries. Bankruptcy/Corporate Restructuring

Richard Levy, a preeminent corporate attorney whose practice has focused for over 30 years on corporate reorganization, bankruptcy litigation, debt restructuring, bank regulation and corporate governance, joined the Firm's Bankruptcy/Corporate Restructuring Practice. He was formerly with Altheimer & Gray.

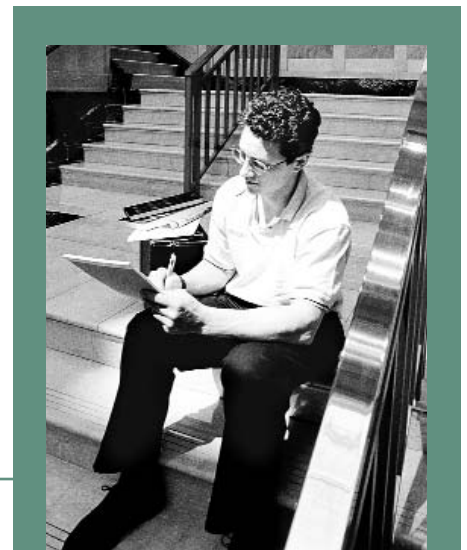

In May, more than a dozen of the Firm's women attorneys and summer associates volunteered their time and energy to improve two transitional living facilities for women and children in Chicago's suburbs, as part of the Third Annual "Women Everywhere: Partners in Service Project," a public service collaboration of 10 women's bar organizations and committees.

Jenner & Block's record of public service work is renowned, and 2002 marked another worthy entry in the tradition of providing pro bono legal services to the indigent, for which the Firm has been recognized for half a century.

Our lawyers again devoted more than five percent of their billable hours to pro bono work, exceeding our commitment as a signatory to the American Bar Association's Pro Bono Challenge.

In doing so, Jenner & Block maintained its ranking among the very top of the *American Lawyer* 100 firms regarding public service work. In December, the Firm again was cited in the *American Lawyer* magazine's annual "Pro Bono

Report" and, in January 2003, the Firm was honored with an annual *National Law Journal* Pro Bono Award.

The Firm provides pro bono litigation and transactional assistance to thousands of individuals and organizations in areas including:

- criminal trial and appellate proceedings;
- death penalty litigation;
- disability-related cases;
- environmental matters;
- family law issues;
- federal appellate litigation;
- hate crimes and sexual harassment cases;
- housing discrimination cases;
- not-for-profit incorporation, property acquisition and tax matters;
- political asylum cases;
- post-conviction and *habeas corpus* litigation;
- prisoners' rights claims; and
- representation of artists and arts organizations.

In 2002, we continued our work on behalf of indigent people fleeing injustice in their homelands, winning asylum and other important decisions for clients including:

A Mauritanian man of Fulani descent who was arrested due to his ethnic background, beaten, and deported to Senegal. An Immigration Court judge granted our client asylum after our team's first witness testified, and he now lives in Moline, Illinois.

A political activist from Guinea who had been kidnapped by local police, jailed, beaten, tortured and threatened with death while being interrogated over a seven-week period. Firm attorneys represented our client at his hearing, won him political asylum and now are helping to reunite him with his wife and children.

An Iowa-born woman of Latvian descent whose application for a security clearance had been denied by the Department of Defense based on her dual citizenship and involvement with Latvian groups. After the Firm intervened, the security office changed its decision and awarded the clearance without a hearing, saving the job of our client.



In August, Jenner & Block sponsored the 2002 Chicago River Flatwater Classic canoe/kayak race, the only one of its kind in the city, and fielded a team of 10 attorneys, staff and summer associates to compete in the voyageur canoe category. Friends of the Chicago River, which coordinates the race, works to improve the river and its watershed through education, private projects, and policy and planning efforts.



Among our asylum clients were two women and one man from Congo who had fled to America to escape political, social and ethnic persecution including beatings, the destruction of their homes and the murder of family members. Jenner & Block attorneys filed applications, attended interviews and finally won asylum for their three clients, who now are living in the Chicago area.

Firm attorneys also provided pro bono legal services in a variety of transactional matters in 2002, such as:

- prevailing on a tax appeal to declare exempt the premises of Chicago's Indo-American Center;
- winning recognition as a charitable organization – and subsequently an Illinois tax exemption – for Lambda Legal Defense and Education Fund; and
- negotiating the historic “merger” of three Chicago-area AIDS services organizations into a new combined entity, Vital Bridges.

And we continued to honor our commitment to fulfill the duty incumbent upon all members of the trial bar to ensure adequate representation of indigent defendants in capital crimes and other criminal felony cases.

Among the hundreds of pro bono matters we handled in 2002 were:

In the spring, the Firm's long-time pro bono client, David Gray, finally received a pardon, after spending 20 years in jail for a crime he did not commit. DNA tests had conclusively established Mr. Gray's innocence, causing a court to vacate Mr. Gray's convictions and free him in 1998, but it took three petitions and representation at a hearing to achieve the clemency and finding of innocence that restores him to the position of his fellow citizens.

In the summer, based largely on arguments presented by the Firm, the Illinois Supreme Court held that the state's Post-Conviction Hearing Act does not allow judges to reject petitions challenging criminal convictions – at least not in the initial stage of post-conviction proceedings – simply because they are filed too late.



In June, 55 Firm attorneys, summer associates and staff members volunteered at the Greater Chicago Food Depository, packing 9,600 meals of donated food for delivery to homeless shelters, soup kitchens, senior centers and other groups around the metropolitan area.

In the fall, the United States Supreme Court agreed to hear Maryland Death Row inmate Kevin Wiggins' argument that his trial counsel was constitutionally ineffective for failing to investigate mitigating evidence in preparation for his death sentence hearing after he was convicted of a 1988 murder. The Firm has been arguing for years on behalf of its pro bono client that Mr. Wiggins' trial counsel should have, but did not, investigate and present powerful available mitigating evidence, including the former house painter's abandonment by his mother, child abuse, sexual abuse by foster parents, homelessness and borderline mental retardation.

The Firm also won a significant victory in the fall when its long-time pro bono clients Henry and Juan Johnson were released on bond. Earlier in the year, an Illinois appellate court vacated the murder convictions against the brothers after finding that new eyewitness evidence gathered after their 1991 trial likely would have changed its outcome.

Also in the fall, the State of Illinois held extensive hearings during which the Firm represented three Death Row inmates seeking clemency. Over the years, more than 100 Firm attorneys, paralegals, project assistants and summer associates worked on those three pro bono cases.

The unprecedented hearings were held after the Commission on Capital Punishment, co-chaired by Firm Partner Thomas Sullivan, issued an internationally-acclaimed report in April that raised significant questions about the fairness of the imposition of the death penalty and inspired a national debate on the issue.

Upon the release of the report, Mr. Sullivan, a former U.S. Attorney, was widely quoted in the national news media. “In medical terms, our report calls for triage, an attempt to staunch the

extraordinary rate of errors, reversals and convictions in capital cases,” he was quoted as saying. “The message from this report is clear: Repair or repeal. Fix the capital punishment system or abolish it. There is no other principled course.”

The Commission's report, called by the *Chicago Tribune* “the product of two years of research and study into the state's troubled death penalty system,” made 85 recommendations, including reducing the number of crimes eligible for the death penalty from 20 to five and banning the execution of the mentally retarded.

Following the release of the report, the state's incoming Senate President announced that the Illinois General Assembly would consider legislation based upon the recommendations of the Commission.

At the American Bar Association's Midyear Meeting in Philadelphia, the National Association of Women Lawyers honored **Stephanie Scharf** with its Outstanding Member Award.

March

Partner **Daniel Murray**, Co-Chair of the Firm's Bankruptcy/Corporate Restructuring Practice, was inducted into the American College of Bankruptcy's Thirteenth Class of College Fellows.

April

The Chicago Audubon Society presented its annual Protector of the Environment Award to Associate **Steven Siros** and Partner **James Vroman**, Co-Chair of the Firm's Environmental, Energy and Natural Resources Law Practice, for their pro bono work to compel the Village of Glenview and the Illinois Department of Environmental Resources to mitigate the adverse impacts of a commercial development on a tall grass prairie that is listed on the Illinois Natural Areas Inventory.

The Illinois Governor's bipartisan Commission on Capital Punishment – co-chaired by Jenner & Block Partner **Thomas Sullivan** – issued its acclaimed report finding that the state must implement sweeping changes in the criminal justice system to ensure fairness in how it imposes the death penalty.

The commission's widely-anticipated 207-page report was the product of two years of research and study, and has been called "perhaps the most comprehensive study of capital punishment prepared by a governmental body."

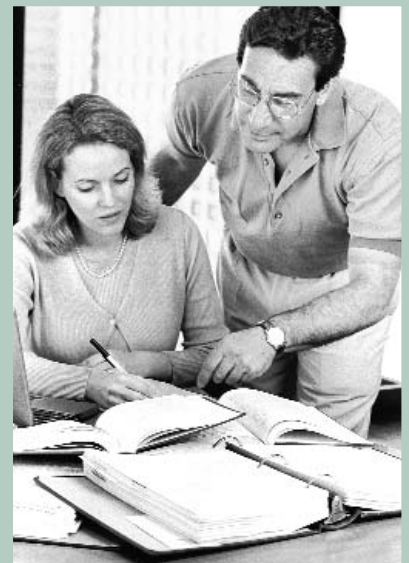
May

June

For the first time, the Jewish Theological Seminary's Judge Simon H. Rifkind Award was given to an attorney who practices outside New York City. The Award was presented to Jenner & Block Chairman **Jerold Solovy** in recognition of his "exemplary life marked by professional preeminence, distinguished public service and unstinting devotion to the community."

The *Washington Post's* "Revisiting Watergate" Section on June 17 featured a historical photograph of the Firm's late Name Partner, **Albert E. Jenner, Jr.** in his role as chief special counsel to the minority of the U.S. House of Representatives Judiciary Committee in its inquiry regarding the impeachment of President Nixon.

The Firm awarded its first annual Albert E. Jenner Pro Bono Award, given to lawyers who provide exceptional legal services to the indigent, to Associate **Christopher O'Connor** and Partner **Richard Steinken**, for their pro bono representation of the defendant in two month-long jury trials in 2001. Barry Levenstam, Co-Chair of the firm's Pro Bono Committee, called their work on the case "an exceptional commitment to the administration of justice."

Jenner & Block was lauded for its support of gay/lesbian issues by *Diversity & The Bar* magazine, a Minority Corporate Counsel Association publication.

July

The *National Law Journal* named Partner **Craig Martin** one of the 40 most promising young litigators in the

country. The magazine noted that each lawyer selected for the honor "has had substantial success already and is expected to lead the nation's litigation bar for decades to come."

October

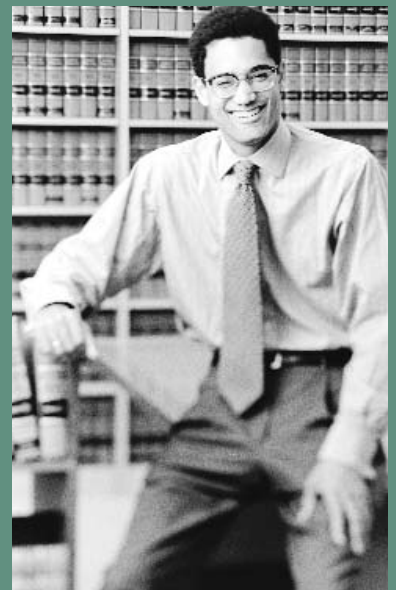
