Undisclosed, produced by lawyers Rabia Chaudry, Colin Miller, and Susan Simpson, re-investigates the cases of people convicted of crimes they say they did not commit, working directly with innocence projects, defendants, and their families across the country. Over more than ten years, the podcast's investigations have contributed to 15 exonerations, two stays of execution, a commutation from death row, a sentence commutation, a Juvenile Justice Act resentencing, a grant of parole, and a vacated conviction.
