Overview

Lindsay has argued in front of the US Supreme Court and federal Courts of Appeals, and has led lawsuits against or involving the government. She led the Jenner & Block team that won a major victory preserving the DACA program in the US Supreme Court after the government in 2017 attempted to rescind the program. Currently, among other matters, she is defending a hotel management company in several litigation matters in Napa County, California. She is also representing Amtrak in litigation to acquire the leasehold interest in Washington, DC's Union Station. And she is also representing pro bono physician witnesses providing evidentiary support to the US Department of Justice litigation challenging the lawfulness of state laws criminalizing reproductive freedom. She also frequently handles consumer class actions of all types, including data breaches, consumer fees, and advertising practices.

Representative Matters

Won a legal challenge to rescission of the DACA program on behalf of Princeton University, a Princeton graduate, and Microsoft. The theory advanced in the firm's Supreme Court brief became the basis for the Chief Justice's majority opinion affirming DACA.

Achieved reversal of a criminal conviction of a company and individual for violating the Arms Export Control Act. Secured a 3-0 decision in the DC Circuit vacating the convictions on the basis that the district court violated defendant Sixth Amendment rights.

Won preliminary injunction for Marriott requiring owner to specifically perform a hotel management agreement obligation to fund working capital at the Hotel in precedent-setting decision applying Maryland law.

Represented Hyatt in litigation brought by a joint venture partner concerning management of the jointly-owned hotel, securing dismissal of the complaint with prejudice in 2020, and subsequently defended the dismissal of the lawsuit on appeal to the New Jersey intermediate appellate court.

Won dismissal of fraud litigation against individual client based on the United States' assertion of the state secrets privilege and won appeal affirming dismissal in published First Circuit opinion.
