

Florida Supreme Court to Hear Oral Arguments in 15-Week Abortion Ban Challenge

On Friday, September 8, the Florida Supreme Court will hear oral arguments in *Planned Parenthood of Southwest and Central Florida, et al. v. State of Florida, et al.*, a case challenging Florida's House Bill 5 (HB 5) which bans abortion after 15 weeks of pregnancy. The 15-week ban, which has been in effect since last July, has harmed patients across the state. While the case challenges a 15-week ban, the impacts of the state supreme court's decision could go far beyond that. If the court upholds the 15-week ban or dismantles the state constitutional right to abortion, a six-week ban signed into law by Gov. Ron DeSantis earlier this year will be triggered and will go into effect soon after — pushing care out of reach for countless more people, including those who haven't yet realized they're pregnant.

Jenner & Block is working in partnership with American Civil Liberties Union, ACLU of Florida, Center for Reproductive Rights, and Planned Parenthood Federation of America, to challenge this state law.
