

# American Constitution Society's Chicago Chapter Honors Bob Graham with Abner Mikva Award

Of Counsel Bob Graham will be honored with the 2023 Abner J. Mikva Award at the American Constitution Society (ACS) Chicago chapter's annual Legal Legends Luncheon on September 12. The award recognizes Chicago-area lawyers and judges who have made extraordinary contributions to progressive legal causes.

Bob founded the firm's Environmental, Health, and Safety Practice and is a nationally recognized authority on environmental, health, safety, natural resources, and energy matters. A sought-after thought leader, he co-authored an environmental law textbook that has been used in many of the nation's law schools. He has served on the boards of the Environmental Law Institute, the Northwestern Center on Wrongful Convictions, the Lawyers' Committee for Civil Rights Under Law, Shepard's Environmental Liability in Commercial Transactions Reporter, and the Institute for Psychoanalysis. For 15 years, he was a member of the Illinois Supreme Court Committee on Civil Pattern Jury Instructions. He also served as a Managing Partner of the firm from 2000 to 2005.

The ACS advocates for laws and legal systems that strengthen our democratic legitimacy, uphold the rule of law, and pursue equality. Hon. Abner J. Mikva, a former congressman, federal judge, White House legal counsel and law professor, was instrumental in creating the ACS.
