

Jenner & Block Represents Albertsons in \$1.9 Billion Comprehensive Divestiture Plan With C&S Wholesale Grocers

With counsel from a Corporate Practice team, The Kroger Co. (NYSE: KR) and Albertsons Companies Inc. (NYSE: ACI) have entered into a definitive agreement with C&S Wholesale Grocers, LLC for the sale of select stores, banners, distribution centers, offices, and private label brands as a key step in their merger process.
