

# *Law360* Highlights Arrival of Jon Skladany to Jenner & Block

In the article, Jon is quoted as saying that he was eager to “return to the world of congressional oversight” and excited to reconnect with former Hill staff colleagues who now work at Jenner. Partner Emily Loeb, who chairs the Congressional Investigations Practice and co-chairs the Government Controversies and Public Policy Litigation Practice, told *Law360* that Jon brings a unique set of skills: “While the oversight panel is the House's primary investigative committee, the Financial Services Committee ‘is also critically important in the execution of the House's oversight responsibilities,’ particularly in the areas of fintech, crypto and emerging technologies.” Jon observed that, today, congressional investigators are not just seeking information about federal programs, “they're asking questions directly to the private sector, about their policies and practices on things like ESG [environmental, social and corporate governance].” He added that he expects this trend to continue “throughout the remainder of this Congress.”
